PRESENTATIONS, PETITIONS AND COMMUNICATIONS

Mayor Gover opened the floor for Public comments. Mr. Ed Dowd, Executive Director of the Mattoon Chamber of Commerce, by virtual attendance mentioned Governor Pritzker's Restore Illinois Plan which continued to allow restaurants to provide carry-out and would call for dine-in after June 28th if virus cases were reduced. Mayor Gover acknowledged the need to open everything as soon as possible, but the City would follow Governor Pritzker's Executive Orders. The Council and Director Dowd continued discussion on the Chamber's efforts to request reconsideration without causing repercussions. Mayor Gover called for further comments without response.

Pursuant to the authority vested in the office of Mayor by the Illinois Municipal Code Section 5/11-1-6, the Illinois Emergency Management Agency Act Section 3305/11 and Ordinance No. 2020-5430 of the City of Mattoon, I, Timothy D. Gover, the Mayor of the City of Mattoon do hereby declare that a Local State of Emergency exists as of this date, May 05, 2020, and shall continue until such time as provided in Ordinance No. 2020-5430.

WHEREAS, on January 30, 2020, the World Health Organization declared the outbreak of COVID-19 to be a public health emergency of international concern and on March 11, 2020 declared a worldwide pandemic; and

WHEREAS, on January 31, 2020, the U.S. Health and Human Services Secretary declared a public health emergency for the United States; and

WHEREAS, the Governor of the State of Illinois has issued a disaster proclamation on March 9, 2020 due to the impact of the COVID-19 virus and has activated the State Emergency Operations Center; and

WHEREAS, the State Emergency Management Agency has declared a public health emergency due to the impact of the COVID-19 virus; and

WHEREAS, the City Administration has coordinated its response with other Coles County governmental entities.

The nature of the emergency is related to the COVID-19 virus which is causing or anticipated to cause widespread impacts on the health of members of the community.

During the existence of the Local State of Emergency, the Mayor shall execute such authority as provided under the Illinois Municipal Code, the Illinois Emergency Management Agency Act and Ordinance No. 2020-5430.

This Declaration of Local State of Emergency shall be filed with the City Clerk as soon as practicable.

Mayor Gover opened the floor for questions/comments/discussion. Council and Administrator Gill re-examined the Mayor's rights and need for possible grant funding, small business grants and FEMA grants due to the reduction of revenues.

Mayor Gover declared the motion carried by the following vote: YEA Commissioner Cox, YEA Commissioner Graven, YEA Commissioner Hall, YEA Commissioner Owen, YEA Mayor Gover.

Commissioner Owen seconded by Commissioner Cox moved to approve Council Decision Request 2020-2039, approving a water and sewer billing adjustment in the amount of \$1,020.83 on behalf of Mattoon Rentals.

Mayor Gover opened the floor for questions/comments/discussion. Mayor Gover noted the Council approval was due to the adjustment being over \$1,000.

Mayor Gover declared the motion carried by the following vote: YEA Commissioner Cox, YEA Commissioner Graven, YEA Commissioner Hall, YEA Commissioner Owen, YEA Mayor Gover.

DEPARTMENT REPORTS:

CITY ADMINISTRATOR/COMMUNITY DEVELOPMENT noted many phone calls due to the Governor's orders, upcoming Zoom union negotiations with AFSCME, grievance filed by the Fire Department, and Fire entry-exams scheduled for July 11th. Commissioner Cox expressed his disappointment of another grievance filed by the Fire Union with the uncertainties of the city. Mayor Gover opened the floor for questions with no response. Mayor Gover vouched for the non-stop telephone calls.

CITY ATTORNEY had nothing new to report. Mayor Gover opened the floor for questions with no response.

CITY CLERK noted the processing a new hire and couple of retirements; otherwise, business as usual. Mayor Gover opened the floor for questions with no response.

FINANCE noted per Commissioner Owen's request the major sources of revenue and would update the schedule at each meeting, updated Council on the General Fund unrestricted cash balance of \$4.4 million compared to the end of March at \$4.9 million. Mayor Gover opened the floor for questions with no response, and noted Director & Treasurer Wright would continue to monitor the revenues.

PUBLIC WORKS noted IDOT conducted a pre-construction conference on the Bike Trail construction with a May 26th start date, Marshall Avenue construction to commence on June 8th, Public Works staff was well and working, and the upcoming Champaign Avenue Sidewalks project to be bid. Commissioner Owen inquired as to the starting point of the Bike Trail project with Director Barber stating an unknown starting point, but NeCo was from Charleston.

FIRE Commissioner Hall noted the attempt to hire in July, interviewing for Fire Chief next week, and Administrator Gill's attempt to support the Fire Department with assistance from the shift captains. Mayor Gover opened the floor for questions with no response. Mayor Gover read an excerpt from a letter from one of the firefighters regarding Administrator Gill as 'Unfortunately, I thought I was speaking to a individual across his desk that had the same morals and ethics that I do. Which now I realize he does not.' Mayor Gover expressed his disdain and refuted the accusation.

POLICE reported all were healthy and noted his work with Administrator Gill over ten years and never doubted his word. Mayor Gover opened the floor for questions with no response.

ARTS AND TOURISM Commissioner Hall noted the navigation and attempt to salvage tourism for this summer, noted providing service and promoting Mattoon, announced not immediately replacing the Arts Coordinator position due to her resignation for another job.

COMMENTS BY THE COUNCIL

Commissioner Hall remarked on the First Responders' efforts and how lucky we were for the quality of service; and noted the Rotary Club's delivering of meals to the First Responders. Commissioner Owen announced the open Water Meter Reader position and elaborated on the IML's predictions for this year's funding which indicated a reduction of Income, Use and PPRT taxes by \$300,000 and the State's Sales Tax reduction of approximately \$1 million, resulting in the City's budget overestimated revenues of \$1.7 million for FY21 and the expectation of revenues only getting worse. He added a request to Senator Righter for Department of Revenue estimates of sales taxes more directly instead of currently running three months behind. Council discussed the delays in State information. Commissioners Cox and Graven had no further comments.

Commissioner Hall seconded by Commissioner Cox moved to adjourn at 7:02 p.m.

PUBLIC HEARING – GRANTS

Downstate Small Business Stabilization Program through the Community Development Block Group funds offered by the Department of Commerce and Economic Opportunity.

Mayor Gover opened the City of Mattoon Public Hearing on the Downstate Small Business Stabilization Program through the Community Development Block Group funds offered by the Department of Commerce and Economic Opportunity at 4:35 p.m. in the City Hall Council Chambers. Mr. Kelly Lockhart, Executive Director of Coles County Regional Planning and Development Commission, explained how the City of Mattoon was applying for the Downstate Small Business Stabilization Program through the Community Development Block Group funds offered by the Department of Commerce and Economic Opportunity, due to the COVID-19 outbreak and its impact on small businesses. The State is making available a total of \$20,000,000 for the Downstate Small Business Stabilization Program.

The City would be applying for six grants in Round Two for:

- 1. Village VII, Inc. d/b/a Alamo Steakhouse and Saloon in the amount of \$25,000 of assistance, where the grant funds will be used for personnel, occupancy, inventory, professional fees, and merchant account fees. This grant will benefit the City of Mattoon and will assist the business to stay open and retain employees during this difficult time.
- 2. J&L Hub, Inc. d/b/a Hubbartt's Downtown Diner in the amount of \$25,000 of assistance, where the grant funds will be used for personnel, fringe benefits, occupancy and utilities, telecommunications and internet, inventory, supplies, equipment, and insurance. This grant will benefit the City of Mattoon and will assist the business to stay open and to retain employees during this difficult time.
- 3. The Ice House of Mattoon, Inc. d/b/a Triple Nickel in the amount of \$25,000 of assistance, where the grant funds will be used for personnel, occupancy and utilities, inventory, supplies, and other miscellaneous expenses. This grant will benefit the City of Mattoon and will assist the business to stay open and to retain employees during this difficult time.
- 4. Elliott Furniture in the amount of \$25,000 of assistance, where the grant funds will be used for rent or mortgage, utilities, telecommunications and internet, inventory, supplies and other miscellaneous expenses. This grant will benefit the City of Mattoon and will assist the business to stay open and to retain employees during this difficult time.
- 5. Gaines Photography in the amount \$25,000 of assistance, where the grant funds will be used for personnel, occupancy and utilities, telecommunications, supplies, and other miscellaneous costs. This grant will benefit the City of Mattoon and will assist the business to stay open and retain employees during this difficult time.

6. Tacos Amigos in the amount of \$25,000 of assistance, where the grant will be used for personnel, supplies, rent and utilities, training and educations, and other miscellaneous costs. This grant will benefit the City of Mattoon and will assist the business to stay open and to retain employees during this difficult time.

The City of Mattoon has provided a detailed prioritized list of community development and housing needs in the community as 1. Road and sidewalk repairs and improvements, 2. Storm sewer improvements, 3. Commercial and Industrial Development expansion and retainment, 4. Housing rehabilitation projects, and 5. Sanitary system improvements. The proposed grants will assist each of the businesses in re-opening successfully once deemed appropriate.

Mayor Gover inquired as to the DCEO's results of the grants with Director Lockhart estimating within the next few weeks. Mayor Gover opened the floor for questions from the Council and Public. With no further questions or comments Mayor Gover closed the Downstate Small Business Stabilization Program through the Community Development Block Group funds offered by the Department of Commerce and Economic Opportunity Public Hearing at 4:40 p.m.

WHEREAS, the City Administration has coordinated its response with other Coles County governmental entities.

The nature of the emergency is related to the COVID-19 virus which is causing or anticipated to cause widespread impacts on the health of members of the community.
