The State is making available a total of \$20,000,000 for the Downstate Small Business Stabilization Program.

The City would be applying for a total of one grant in Round Three for:

1. Harold E Shores Jewelry is in need of \$11,100.00 of assistance. The grant funds will be used for personnel, occupancy, telecommunications & internet. This grant will benefit the City of Mattoon and will assist the business to stay open and retain employees during this difficult time.

The City of Mattoon has provided a detailed prioritized list of community development and housing needs in the community as 1. Road and sidewalk repairs and improvements, 2. Storm sewer improvements, 3. Commercial and Industrial Development expansion and retainment, 4. Housing rehabilitation projects, and 5. Sanitary system improvements. The proposed grant will assist the business in re-opening successfully once deemed it is safe to do so.
